Summer/Fall 2016 Registration Calendar

REGISTRATION PERIOD	DATE	WHO CAN REGISTER?
Priority 1	May 6, 9, 10	CalWORKS, DRC, EOPS, Foster Youth, Veterans (see notes below for additional eligibility criteria)
Priority 2	May 11	Athletes, MESA, Puente, TRIO (see notes for additional eligibility criteria)
Priority 3	May 12-13	Continuing, new to college who have completed assessment, orientation (Kick Start <u>and</u> GUID 210, 6 or KIN 1 + comprehensive ed plan), GECA (see notes for additional eligibility criteria)
Priority 4	May 16	New to college students (incoming), and continuing who have not completed assessment+orientation+comprehensive ed plan
Priority 5	May 17	Returning, Transfer, Probation 2 and Academically Dismissed, High School (except GECA) and those with 100+ units.
Late	June 20 (Su), Aug 29 (Fa)	Students who have obtained add codes from instructors
Open – entry/late-start	Before first day of class	All students taking open-entry and late-start classes

NOTES:

- Continuing students eligible during Priority 1, 2, or 3 registration must be in good academic standing and have less than 100 earned units total (excluding 30 units basic skills or ESL classes).
- Students on probation for 2 consecutive semesters or on academic dismissal may enroll at Priority 5.
- New to college students for Summer or Fall 2016, and who are eligible for Priority 1, 2, or 3 registrations, must have successfully completed an assessment, orientation (Kick Start and GUID 210, 6 or KIN 1) and a comprehensive education plan to be eligible for priority registration. New to college students who have not successfully completed those three components may enroll during Priority 4 registration which starts on May 16.

Wednesday, August 3, 2016 (2:30pm)	July 13 (5:01pm) to August 3, 2016 (2:29pm)	Fall Classes Only
Wednesday, August 17, 2016 (2:30pm)	August 3 (5:01pm) to August 17, 2016 (2:29pm)	Fall Classes Only

NOTE: Students must pay for ALL classes, including classes added after initial registration to prevent being dropped from classes during the drop for nonpayment dates listed above. The system shuts down between 2:30pm and 5:00pm on the Drop for Nonpayment Dates. Payments must be made PRIOR to 2:30pm on those days to avoid drop for nonpayment.

All students may go online to purchase a parking permit. Students can print out a temporary permit to use while waiting to receive the official permit in the mail. They will be notified by email when they submit their order, and again the day the permit is scheduled to arrive in the mail. Permit arrives in approximately 7 business days after online order is placed.
