The ISER's first few pages discuss the history and story of our campus, this is a great place to begin if you're interested in understanding the message and purpose of the visit. (3) Measure X website is up and running. Bonds are currently being packaged and prepared for sale. Upon selling of the bonds, the San Benito County Campus begins construction. (4) Dr. Rose is receiving the Educator of the Year award from the Morgan Hill Chamber of Commerce at Guglielmo winery in Morgan Hill, begins at 6:00 p.m.-10:00 p.m.

- 6.1 <u>ASGC President currently working on the program for the Symposium.</u> Met with VPs Hernandez, Togliatti and Advisor Arteaga to discuss the Symposium. Food selection has been made and there has been an increase in the number of participants signed up. We are currently looking for volunteers to mentor/guide students on the day of the Symposium from 9:00-3:00. I was unable to attend the Region IV meeting due to personal conflicts. I met with Debbie Klein to strategize for the A&P conference this weekend in which VP Franco and I will be attending in Sacramento on Sunday and Monday. Senator Zuniga has decided to step down until further notice, thus the Senator of Marketing position is now vacant. I am working on developing a survey for Gavilan students that will identify attitudes, obstacles, and interests in student government; hopefully this data will provide next year's Senate with some key insight into why so few students participate in student government on our campus.
- 6.2 <u>Student Trustee</u> Tuesday attended Institutional task force meeting working to minimize adjustments to the budget due to the new funding formula. - 6.4 <u>VP of Clubs Currently</u> have 14 active clubs. LIT society and Ambassadors club are restarting. Club Day is on March 12th and the theme is Candy Land "Gavi-land".

- 8.1 Graduation Planning, Advisor Arteaga (30 mins)
  - 8.1.1 Graduation will be Friday, May 24th at 3:00 p.m. on the Soccer field. The layout has changed. Students will be registering on an EventBrite site in order to walk site to come. Two parking permits will be given to students, if you are on campus already please park in Lot A. ASGC is responsible for planning the rehearsal and reception. Wade Ellis is looking into alternate parking. Highest GPA in a respective major will carry the major-related sign. Graduation flyer should be developed in later months to notify students about information regarding graduation. Graduation committee will be on Friday the 22nd at 1:00 p.m.
  - 8.1.2 Reception food last semester was a little under \$2,600 we spent a \$1,020 for the DJ and Photo Booth. VP Franco will look into acquiring sponsorships for the graduation reception. Have this as a returning agenda item for next week. Senate is currently looking for a potential new DJ and Photo Booth. Advisor Arteaga will request a quote from the cafeteria with regards to food. Quotes for the photobooth will be due next week on 3/8. Requisition needs to be submitted by the end of March. Advisor Arteaga will follow up about acquiring volunteers for graduation reception.
  - 8.1.3 Graduation stoles senate members should develop their own design with the link provided and bring their design to the following senate meeting. Senate will determine which stole to purchase.
- 8.2 Funding New ASGC Incentives, President Golden (30 mins)
  - 8.2.1 Monthly Gas Card or Bus Voucher, \$25/month 8.2.1.1 \$3,300/year for all 11 VP positions.
  - 8.2.2 Automatic Recipient of ASGC Textbook Scholarship 8.2.2.1 \$2,200/year for all 11 VP positions.
