- 8.1 Food Pantry Expanded Services, Annette Gutierrez (5 mins)
 - 8.1.1 Receiving fresh produce on first Tuesday (10:30-4:30) out of the FP and Just in Time (chicken, eggs, milk. produce, non-perishables) on third Thursday of the month (12:30-2:30). Food is available for 50 families, on a first come first serve basis. Volunteers still needed and advertisement for students. Most of the individuals who utilize these services are members from the community and not necessarily students on campus. Also assisting with the CalFresh applications on the spot. Hours are posted on the Gavilan.edu/foodpantry.
